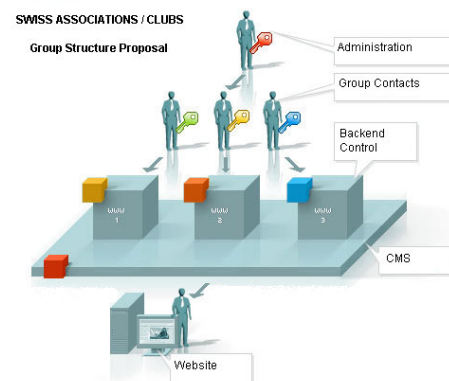


### Swiss Academics (SAE 2008) – Oct. 22, 2008

Dr. Thomas Bissig, Director of Research & Education represented our Chamber at this strategic meeting hosted by Mr. Walter Deplazes, Consul General of Switzerland in Vancouver. The discussion included participation of Christian Simm, executive director of Swissnex, San Francisco and Sebastian Hug, scientific attaché of the Swiss Embassy in Ottawa amongst numerous other delegates. The plan is to create a group called "Swiss BC Academic Group" or SBCA which would explore avenues like a collaboration in fuel cell research between Switzerland and Canada (PSI, ETH) together with the National Research Council of Canada's Institute for Fuel Cell Innovation (NRC-IFCI). The Swiss and Canadian Academics plan to meet again in Spring 2009 to further explore the creation of such an association.

### Swiss Presidents Meeting – Dec. 15, 2008

The heads of the Swiss Society of Vancouver (SSV), Vancouver Dorfmusik, Swiss Choir, Seniors Club, Swiss Canadian Mountain Range Association (SCMRA) and of course the Swiss Canadian Chamber of Commerce (SCCC), met together in the offices of the Consul General of Switzerland to discuss future collaboration of the various Clubs and Organizations in Vancouver and to possibly include the rest of BC as well as AB. An agreement in principal was achieved to create a centralized access point (online portal / content management system), providing consolidated access to the respective organizations. The expertise of our Director, Erich Amgwerd and Konrad Iten of the Swiss Society of Vancouver was requested to discuss and mediate such a solution. We will be investigating various technologies, costs and creating a project plan to structure such a technology. Also discussed was the hiring of an administrator / secretary to be shared amongst the associations. Stay tuned for more...
